Dear Parent / Guardian,

Did you know that Child Nutrition Services serves over a Half Million Total Meals a Year! Approximately 60 Dedicated Employees work as a team to provide nutritious meals to students, staff and guests.

Child Nutrition Services has a fiscal responsibility to stay in compliance with Federal Guidelines. In order to meet this obligation, parents / guardians are responsible for purchases made by their student(s) in the cafeteria. It is not Boerne Independent School District's intent that children go hungry at school; however, it is the responsibility of parents or guardians to provide their children's lunch or breakfast or pay for meals provided by your school.

## Please review the following BISD Charge Policy & Courtesy Meal Information:

When a meal account becomes negative, the household will be notified by letter, e-mail or phone call.

Students will be allowed a maximum of three (3) lunch meal charges according to the grace period set by the school board.

After a student has accrued three (3) lunch meal charges, a courtesy meal consisting of a sliced meat & cheese sandwich, fruit or vegetable and milk will be offered at no charge. Students will continue to receive a courtesy meal until all cafeteria charges are paid. **No a la carte items may be charged at any time.** It is department policy not to take away a food tray once a student has received it.
